## *GROUP PROGRESS NOTE*

Notes written by counselors for group sessions serve a few different purposes. The primary purpose of group counseling notes is to help the client and keep track of his or her progress toward meeting treatment goals 1. These notes are also used to document a client's use of services for payment purposes, generally from insurance companies.

## *How to Write Group Counseling Notes | Healthfully*

The following kinds of information go in a progress note (further guidelines and examples appear below). ? counseling session start and stop times, ? medication prescription and monitoring ? the modalities and frequencies of treatment furnished, ? results of clinical tests, and ? any summary of the following items: o Diagnosis, o functional status, o symptoms, o prognosis, and o progress to date.

PROGRESS NOTE (GIRP FORMAT) Client will identify three triggers of substance use in order to reduce risk of relapse, and will increase control over cravings, as evidenced by using learned coping skills from 0 times per day to 3x per day. He will decrease depressive symptoms by engaging in positive social interactions 1x per week.

*SUBSTANCE ABUSE PREVENTION AND CONTROL PROGRESS NOTE (SOAP ...*

Progress Note is signed and dated Date of service, time spent, and location Strengths observed. Addresses any outstanding issues from previous progress note. Documentation of any significant life events (successes and/or barriers). Identification of any necessary changes to the goals/action plans. Includes a summary/discussion of

*The Write Stuff: Intake Notes, Progress Notes, and Group Notes*

One example is using a SOAP note, where the progress note is organized into Subjective, Objective, Assessment, and Plan sections. The progress notes focus on the objectives stated in the nursing care plan. The objectives may include, the response in prescribed treatments, performing daily activities, and Understanding of a particular condition.

## *EXAMPLE S.O.A.P. NOTE*

Progress Note Sample - SOAP (Subjective, Objective, Assessment, Plan)  
SUD Goal - In client's words: "I want to stop fighting with my wife and get my job back so I have to stop using." S (Subjective) - Counselor/clinician records what the client says

## *Documentation of Substance Use Disorders: Progress Notes*

Group Notes: This type of note is entered into an Encounter Note. All treatment group notes must be in DAP format. Information recorded must include a summary of what happened in group. The Group note is to be completed within the same business day as the group was held (or last group held in a work week for Residential/Halfway House group notes.)

## *Progress Notes Procedure - ASAC*

A SOAP note is a progress note that contains specific information in a specific format that allows the reader to gather information about

each aspect of the session. Now, to be honest, most clinicians weren't "trained" on SOAP notes as part of graduate training. Chances are you picked up some therapy note-taking skills along the way.

Review the progress and note specific treatment goals that have been reached. For example, if a goal was to use regular exercise as a treatment for depression, you can assess the extent to which the client has reached this goal. You'll need to summarize the client's initial reason for seeking therapy and the length of time she attended counseling.
