The UK has a number of laws which apply particularly to computers and networks: Computer Misuse Act 1990 - creates offences of unauthorised access and interference with computers and data Communications Act 2003 - creates offences of improper use of a public communications service (s.127) and dishonestly obtaining electronic communications services (s.125)
